SUBJECT: REVISED CUSTOMS DECLARATION FORM C100

Kindly find attached a copy of the revised Customs Declaration Form C100. This form will be required effective **01 November 2010** for the import/export of goods.

Due to limitations with regards to space in boxes 31 to 35 and 40 to 42 on the existing form, the form has been modified to accommodate the various taxes which Customs is mandated to collect. Whereas the existing form had space for four (4) items, the revised form has space for three (3) items only. Likewise the continuation sheet had space for six (6), it now has space for five (5) items.
