Immigration (Common CARICOM ED) Forms Regulations

In exercise of the power conferred by section 31.(1)(c) of the Immigration Act, No. 10 of 2002 the Minister makes the following Regulations:

[Published 12th January 2007, *Extra Ordinary Gazette* No. 3 of 2007]

1. **CITATION.** These Regulations may be cited as the Immigration (Common CARICOM ED) Forms Regulations, 2007.
2. **COMMENCEMENT.** These Regulations shall come into force on the 15th day of January 2007.
3. **INTERPRETATION.** In these Regulations, the term "ED card" means the embarkation cards completed by passengers upon arrival or departure from the State.
4. **INTRODUCTION OF COMMON CARICOM ED FORM.** A person entering the State shall be required to complete an ED card in the manner set out in the Schedule.
