The Customs (Prescription of Customs Declaration Forms) Regulations, 2007 made by the Comptroller of Customs under section 86 of the Customs (Control and Management) Act, 1992 (No. 4 of 1992)

- 1. CITATION. These Regulations may be cited as the Customs (Prescription of Customs Declaration Forms) Regulations, 2007.
- 2. COMMENCEMENT. These Regulations shall be deemed to have come into force on the 15th day of January, 2007.
- 3. CUSTOMS DECLARATION FORMS. The form prescribed in the Schedule is the form required to be completed by all passengers entering the Federation of Saint Christopher and Nevis under section 86 of the Customs (Control and Management) Act, 1992 (No. 4 of 1992).
